1. Aims

Schools are required under the Equality Act 2010 to have an accessibility plan. The purpose of the plan is to:

- > Increase the extent to which pupils with disabilities can participate in the curriculum
- > Improve the physical environment of the school to enable pupils with disabilities to take better advantage of education, benefits, facilities and services provided
- > Improve the availability of accessible information to pupils with disabilities

Our school aims to treat all its pupils fairly and with respect. This involves providing access and opportunities for all pupils without discrimination of any kind.

Hempsted Church of England Primary School believes that all pupils and staff should be allowed to reach their God-given potential and 'live life to the full'. This plans sets out how we can support those people who have both short-term and long-term disabilities; it is not exhaustive and will be amended when necessary. For example, when new technology becomes available to help a child with a sensory impairment.

The plan will be made available online on the school website, and paper copies are available upon request.

Our school is also committed to ensuring staff are trained in equality issues with reference to the Equality Act 2010, including understanding disability issues.

The school supports any available partnerships to develop and implement the plan. These can include Advisory Teaching Services (including hearing and visual impairments), school nurses and any other services available to us.

Our school's complaints procedure covers the accessibility plan. If you have any concerns relating to accessibility in school, the complaints procedure sets out the process for raising these concerns.

We have included a range of stakeholders in the development of this accessibility plan, including pupils, parents, staff and governors of the school.

2. Legislation and guidance

This document meets the requirements of <u>schedule 10 of the Equality Act 2010</u> and the Department for Education (DfE) <u>guidance for schools on the Equality Act 2010</u>.

The Equality Act 2010 defines an individual as disabled if they have a physical or mental impairment that has a 'substantial' and 'long-term' adverse effect on their ability to undertake normal day to day activities.

Under the <u>Special Educational Needs and Disability (SEND) Code of Practice</u>, 'long-term' is defined as 'a year or more' and 'substantial' is defined as 'more than minor or trivial'. The definition includes sensory impairments, such as those affecting sight or hearing, and long-term health conditions such as asthma, diabetes, epilepsy and cancer.

Schools are required to make 'reasonable adjustments' for pupils with disabilities under the Equality Act 2010, to alleviate any substantial disadvantage that a pupil with disabilities faces in comparison with a pupil without disabilities. This can include, for example, the provision of an auxiliary aid or adjustments to premises.

3. Audit of current practice and provision.

- The school has an Accessible Toilet that is sufficiently large enough to accommodate a wheelchair and toileting chairs / steps.
- The school has spaces that can create a learning environment that supports the effective delivery of specific training and provision e.g. Speech and Language Therapy, Physio Programmes as well as providing a quiet area to support the needs of pupils with multisensory difficulties such as "loud noise stress".
- There are 2 designated disabled parking spaces.

- 10 members of staff have undertaken Manual Handling (Team Team) Training (Sept 2022).
- All pupils' progress is monitored 3 times per year and more frequently for some SEN pupils. SONAR is used to support this monitoring.
- Staff are implementing the Gloucestershire PinK Curriculum which includes Disability Equality issues.
- Interactive Display Screens are in place in all classrooms.
- Laptop provision for vulnerable children at home.
- There is a Hearing Induction Loop in the hall.
- Hearing Aid transmitter
- Reveal 16 Magnifier
- There are no stairs or steps.
- Furniture such as coat hooks adapted when necessary.
- Steps to allow access to Smartboard, toilets etc when necessary.
- Fizzy sessions to improve fine and gross motor skills.
- Participation in Panathlon events.

Ensuring all pupils can access the full curriculum.
